

SNAPWASH DRIVER INDEPENDENT CONTRACTOR AGREEMENT

1. Independent Contractor Status

Drivers using the Snapwash platform acknowledge that they are independent contractors and not employees, partners, or agents of Snapwash Technologies LLC. Drivers are responsible for their own taxes, insurance, and operating expenses.

2. Eligibility Requirements

Drivers must be at least 18 years old, possess a valid driver's license, maintain valid vehicle registration, maintain automobile insurance, and complete identity verification or background checks if required.

3. Driver Responsibilities

Drivers agree to pick up garments from customers, transport garments to designated laundry partners, and return garments to customers in a safe and professional manner.

4. Chain of Custody

Drivers must follow Snapwash chain-of-custody procedures including scanning items during pickup, scanning when delivering to cleaners, and scanning items during final delivery to customers.

5. Driver Equipment

Drivers are responsible for providing their own vehicle, smartphone, fuel, and transportation-related expenses.

6. Insurance Requirements

Drivers must maintain automobile insurance meeting state legal requirements. Snapwash does not provide automobile insurance coverage for drivers.

7. Payment

Drivers are compensated per completed delivery. Compensation may include delivery fees or incentives. Snapwash reserves the right to modify payment structures.

8. No Guaranteed Earnings

Snapwash does not guarantee drivers will receive a minimum number of delivery requests or earn any specific amount of income.

9. Acceptance of Deliveries

Drivers may accept or reject delivery requests offered through the Snapwash platform.

10. Driver Schedule Control

Drivers control their own schedule and may log in or out of the Snapwash platform at any time.

11. Garment Handling

Drivers must exercise reasonable care when transporting garments and are responsible for garments while in their possession.

12. Driver Conduct

Drivers must act professionally and must not engage in illegal activity, harassment, or property damage while using the Snapwash platform.

13. Platform Use

Drivers may not manipulate the platform, create fraudulent orders, or share driver accounts.

14. Limitation of Liability

Snapwash shall not be liable for vehicle accidents, driver injuries, lost income, or driver expenses.

15. Indemnification

Drivers agree to indemnify and hold harmless Snapwash Technologies LLC from claims arising from driver negligence, vehicle accidents, or violation of laws.

16. Arbitration Agreement

Any dispute relating to the Snapwash platform shall be resolved through binding arbitration. Drivers waive the right to participate in class-action lawsuits.

17. Termination

Drivers may stop using the Snapwash platform at any time. Snapwash may suspend or terminate driver access at any time.

18. Governing Law

This Agreement shall be governed by the laws of the State of New York.
